Category	Photo Identification (Must be current)
	Irish/EU/UK driving licence or learner permit
	Passport (from country of citizenship)
	Irish certificate of naturalisation

	<b>Proof of Address (Dated within six months of date on Vetting Invitation Form)</b>
<b>Credit Institutions</b>	Bank Statement from a recognised bank (not private money lenders or Revolut)
	Building Society Statement
	Credit Union statement
	Credit Union passbooks
<b>Utility Providers</b>	Utility bill (the only utility bills accepted are: gas, electricity, television, broadband, waste & TV licence).

Two documents must be submitted, one to support identification (Photo ID) and one to support proof of address.

### **Applicants Under 18**

Where an applicant under the age of 18 does not have the documentation outlined in the accepted documentation table above, the following will be accepted.

Birth Certificate
Written statement by a school principal or an accredited third level institution confirming attendance and address.
